Recognizing Nonprofit Innovative Excellence

The NOVO Awards are open to not-for-profit organizations and recognize programs and individuals that have made a difference in the lives of the people they serve, produce outcomes that exemplify innovative excellence and feature best practices of not-for-profit businesses.

Awards are presented in three categories:

- Nonprofit program innovative excellence in an organization with a budget of less than \$2 Million
- Nonprofit program innovative excellence in an organization with a budget of more than \$2 Million
- Outstanding Board Leader that exemplifies the best in nonprofit board service

Eligibility Requirements

- The organization must be headquartered or have operations in Miami-Dade County.
- The organization must be a registered 501(C)(3) nonprofit organization and in business for at least two (2) years.
- Past winners are eligible to reapply after a three-year wait.
- Only applications that meet all the requirements and criteria will be considered.

Application Requirements

- Deadline for application submission is **JUNE 30, 2025**
- Application must be complete
- Only one entry per organization may be submitted
- Copy of the organization's 501 (C)(3) IRS Determination Letter must accompany application
- Discretionary: one letter of support
- Application and supporting documentation must be emailed to athompson@miamichamber.com by June 30, 2025.

Award Criteria

Innovative Program Excellence

- Program may be defined as the activities of the organization as a whole or a specific program within the organization
- Program must be a current program being offered by the nonprofit organization.
- Must further the mission of the organization
- Have specific and measurable outcomes
- Demonstrate innovation
- Meet community needs

Outstanding Board Leader

- Furthers the mission of the organization, demonstrates creative leadership and innovation
- Must be a currently active board member (paid staff are not eligible)
- Must be nominated by the nonprofit organization he/she serves or a board peer
- Has shown leadership among colleagues.
- The organization's board must be a governing board with fiduciary responsibility and not an advisory board.

Nominations will be reviewed, and the final selection made by a panel of judges. The top three finalists from each category will be recognized at the Greater Miami Chamber of Commerce Trustee Luncheon on **Wednesday, September 10, 2025**. All finalists are invited to attend.

A cash award of \$1,000 will be presented to the top finalist in each category:

- Nonprofit program innovative excellence in an organization with a budget of less than \$2 million
- Nonprofit program innovative excellence in an organization with a budget of more than \$2 million
- Outstanding Board Leader that exemplifies the best in nonprofit board service
